2 Features

- Video and Audio contents can be delivered to up to 50 tablets in real time synchronously without internet / LAN.
- Easy operation by Power and 4 selectable feature buttons.
- 5GHz Wi-Fi band is adopted in the system to evade RFI (indoor use only).
- 2x Video inputs (switchable), 1080i 60 or 1080p 30.
- High level of security for the contents by using original codec.
- Enlargement / Shrink operations on viewer application
- by pinch-in / pinch-out.
- Q&A function is implemented for presenters to take prompt and effective reactions based on the feedback from the audience.
  - Max. 100 Qs can be set with max. 5 A choices per Q.
  - Each audience can answer Qs through his/her tablet.
  - Reply tabulation is performed in real time.





Image of Q&A screen.
